Please be advised that the revised rate filing for WFG National Title Insurance, 2017-03, CDI #17-6019 has been filed pursuant to California Insurance Code §12401 et seq. *The subject filing provides for an effective date of 10/15/2017*.

The revisions to the manual include the following:

ADDED 4.4 (all sections after were re-numbered)

SECTION 4.4 MULTIPLE LOAN POLICIES

When multiple loans by the same lender to the same owner are processed and recorded concurrently, the charge is the applicable rate, based on the aggregate amount of the loans plus \$100 for each additional policy over one, plus the additional parcel charge, if any.
