1. GENERAL PROVISIONS

When closing and settlement charges of any type are involved, all offices of WFG National Title Insurance Company (the Company) will use the appropriate closing fees as set forth in this manual. All appointed agencies of the Company shall file their own fees and justifications as required by Regulation 8-1-1.

All third party (pass through) charges and costs in connection to a transaction will be charged at the actual cost thereof.

All fees are based on a standard transaction with the average amount of work performed. If additional work is required, the Company will charge for the additional labor fee, as included and defined in this filing.

The closing and settlement fees for residential and commercial properties wil be applied based on the county in which a majority of the closing and settlement services are provided and not the county where the property is located or where the phyical transaction takes place. The closing and settlement fees for residential and commercial properties will be applied based on the effective fee in place at the time the service(s) is ordered.
