As pointed out in [National Underwriting Bulletin 2014-09](#), Illinois gives its condominium and homeowners association liens “Super Priority” ahead of already recorded mortgage interests. In addition to not issuing the ALTA 4 and ALTA 5 endorsements, the ALTA 9-06 and ALTA 9.6-06 endorsements should no longer be issued in Illinois. In their place, the ALTA 9.10-06 and the ALTA 9.6.1-06 endorsements are now available.

In addition, WFG has made available variations of policies which already incorporate the appropriate endorsements for use in a “super priority” state. Those are:

- 3170900** ALTA Short Form Residential Loan Policy - Current Violations (04-02-15)
- 3171000** ALTA Short Form Expanded Coverage Residential Loan Policy-Current Assessments (04-02-15)
- 3171200** ALTA Expanded Coverage Residential Loan Policy - Current Assessments (04-02-15)

The appropriate version of policy jackets should generate automatically through the AMS2 portal, but you will need to coordinate with your software vendor to assure that the most current version of each of the new endorsements has been loaded into your production system.
