To All WFG Agents doing business in Illinois,

It has come to our attention that certain governmental offices that all of us rely on in the Chicago Metro area (Cook County) to conduct business are closing or operating with reduced staff. WFG is committed to provide you with solutions so that you can facilitate transactions through these closures. See below for an update. We will continue to update you as this information changes.

Title commitments with sold taxes in Cook County, should display a tax exception indicating tax information is incomplete. For these files, please work with your Illinois underwriter to set up and approve an appropriate Title Indemnity to close.

Current tax bills and 2018 tax bills can be paid through ACH; any open item or forfeited taxes will need to be mailed in (not FedEx).

The Cook County Recorder of Deeds office is currently CLOSED to the public. Recordable documents can be e-recorded (this would include deeds and mortgages for Cook). You will not be able to e-record a facsimile or a scrivener's affidavit.
