Subject: Fraud Prevention

Unfortunately, at a difficult time in the current real estate market, fraudulent transactions are on the rise. We've seen an increase in alerts of potential fraud from agents across the country.

Here, are a few recent fraudulent sale scenarios that WFG agents have encountered and have halted:

In one case, agent became concerned that Seller was not the true owner of the property based on several red flags, including: (1) Buyer was in another country with an earnest money deposit held up by OFAC; (2) Buyer wanted to send proceeds in a non-traditional way via Bitcoin, Whatsapp, or Zelle and provided a wire not associated with any party to closing; (3) Seller ID appeared electronically altered with different signature and standard details were either missing or out of order; and (4), When agent halted the sale, Buyer did not contest, which led agent to believe it may have been an overall scheme by both Buyer and Seller to complete a fraudulent transaction.

In another case, a few of our agents ran into the same foreign Buyer trying to purchase properties in multiple states via multi-million dollar cash FSBO contracts. When it came time to make contact with Seller, Buyer was elusive and provided incorrect information on Seller.

Now is the perfect time to make sure you ramp up your awareness and evaluate your business practices to best spot potential fraudulent transactions. Take this time to re-review your state underwriting bulletins with cautionary fraud alerts and our national bulletins, which speak to several topics concerning fraudulent schemes.
