The Oklahoma Supreme Court and the Oklahoma Court of Criminal Appeals issued a First Emergency Joint Order Regarding the COVID-19 State of Disaster, dated March 16, 2020 (the "Joint Order"), which is attached <u>Here</u>. The Joint Order: (1) suspends all "deadlines and procedures whether prescribed by statute, rule or order in any civil, juvenile or criminal case", including appellate rules and procedures; (2) extends the statute of limitations in any civil case for 30 days, until April 14, 2020.

Therefore, you cannot rely upon the expiration of these deadlines, including statutes of limitations, occurring on or after March 16, 2020, through April 14, 2020. Please note that the Joint Order can be further extended or revised. This means that you must monitor the Oklahoma State Courts Network website for any extensions or revisions to the Joint Order. Please see <u>www.oscn.net</u> for updates.

In addition, on March 24, 2020, Governor Stitt signed amendments to Executive Order 2020-07, which in part, closes all non-essential businesses and non-critical infrastructure, in an effort to stop the spread of COVID-19. The Order will become effective at 11:59 p.m., March 25, 2020, and non-essential business closures will continue until 11:59 p.m., April 15, 2020. The American Land Title Association ("ALTA") and the Oklahoma Land Title Association ("OLTA"), among other state land title associations, have taken the position that title agents are deemed to be "essential" workers under the U.S. Department of Homeland Security, Cybersecurity & Infrastructure Security Agency ("CISA"). In addition, U.S. Treasury Secretary Steven Mnuchin, issued a Memorandum for Financial Services Sector, dated March 22, 2020, referencing "clearing and settlement services," and "insurance services," as essential functions within the financial services sector. A copy of the memo is available Here. The health, safety and welfare of WFG's employees, agents, customers and vendors are paramount. Therefore, while title agents may be deemed essential workers under CISA, whether a title agent continues to conduct business during this time is a personal decision that should be carefully and thoughtfully evaluated to protect its staff and the public.

WFG is responsibly engaging in social distancing, which includes many of its employees working remotely and temporarily limiting in-person interactions, including meetings, seminars, and speaking engagements. However, it will continue to utilize other means of service and communication to safely serve you.
