

#### **REQUIRED EXCEPTIONS**

# WISCONSIN

Defects, liens, encumbrances, adverse claims or other matters, if any, created, first appearing in the public records or attaching subsequent to the effective date hereof but prior to the date the proposed insured acquires for value of record the estate or interest or mortgage thereon covered by this Commitment.

(Note to Agent: This exception shall only appear on Commitments to Insure.)

## **Standard Exceptions**

- 1. Any rights, interests or claims of parties in possession not shown by the Public Records.
- 2. Any encroachment, encumbrance, violation, variation, or adverse circumstance or other matter affecting the Land that would be disclosed by an accurate and complete land survey of the Land. The term "encroachment" includes encroachments of existing improvements located on the Land onto adjoining land, and encroachments on the Land of existing improvements located on adjoining land.
- 3. Easements or claims of easements not shown by the Public Records.
- 4. Any lien, or right to a lien, for services, labor, or materials in connection with improvements, repairs or renovations provided before, on, or after Date of Policy and not shown by the Public Records at Date of Policy.

#### **Other Required Exceptions**

- 5. Taxes or special assessments not due and payable at Commitment Date.
- For Owner's Policy Only: Taxes and assessments that become a lien against the property after the Date of Policy. The Company assumes no liability for tax increases occasioned by retroactive revaluation, changes in the land or usage thereof or loss of any homestead exemption status of the Land.
- 7. <u>For Loan Policy Only</u>: Those taxes and assessments that become due or payable subsequent to Date of Policy. This does not modify or limit the coverage provided in Covered Risk 11(b).

NOTE: Wisconsin does not permit a standard exception for oil, gas, and mineral rights to be included in an Owner's or Homeowner's Policy. Searches should be carefully reviewed for any and all interests in oil/gas/mineral rights, including but not limited to reservations of interest, statements of claim, and severances, assignments, conveyances and mortgages of the oil, gas or mineral interests. If found, take specific exception.

### **General Exceptions for Residential Refinances Only**

For Loan Policies issued in connection with the refinance of 1-4 family residential, the following general exceptions (General Exceptions) may be used in lieu of searching the required time period for specific easements and restrictions:

- 8. Easements, if any, appearing in the Public Records.
- 9. Covenants, conditions and restrictions, if any, appearing in the Public Records.
- (a) Unpatented mining claims; (b)reservations or exceptions in patents or in Acts authorizing the issuance thereof; and (c) Oil, natural gas, coal, fissionable materials or other minerals previously conveyed, leased or retained by prior owners, whether or not appearing in the Public Records or listed in Schedule B.
